



### **BODY MOUNTING DETAIL**




CUTAWAY SIDE VIEW MOUNTING DETAIL

#### INSTALLATION:

- LOCATE 3/8" x 6" x 12" SHEAR PLATES FORWARD OF CHASSIS SPRING SHACKLES AS SHOWN. BOLT THE SHEAR PLATES USING 5/8-11 GR5 OR EQUAL HEX HEAD CAP SCREWS. TWO [2] BOLTS PER SHEAR PLATES AS SHOWN (LEAVE LOOSE FOR NOW).
- LOCATE BODY ON CHASSIS AS DESIRED. BE SURE TO ALLOW FOR PROPER CAB TO BODY CLEARANCE.
- POSITION SHEAR PLATES TO BODY LONGITUDINAL TUBE AND WELD AROUND PERIMETER (SEE SHEAR PLATE MOUNTING DETAIL).
- TIGHTEN BOLTS ON FRONT FOUR [4] SHEAR PLATES. INSTALL SHIM PLATE BETWEEN SHEAR PLATE AND CHASSIS RAIL, IF THE GAP BETWEEN THEM IS GREATER THAN 1/8" AFTER WELDING THE SHEAR PLATE TO THE LONGITUDINAL TUBE.
- INSTALL THREE [3] 5/8-11 GR5 HEX HEAD CAP SCREWS TO REAR 8" STRUCTURAL CHANNEL SHEAR PLATE AS SHOWN. INSTALL SHIM PLATE BETWEEN CHANNEL SHEAR PLATE AND CHASSIS RAIL, IF THE GAP IS GREATER THAN 1/8" AFTER MOUNTING THE BODY AND DRILLING THE REQUIRED HOLES.
- CHECK ALL BOLTS FOR PROPER TORQUE BASED ON THE TRUCK MANUFACTURER RECOMMENDATIONS.

### TOP COAT PREPARATION

All Venturo bodies receive an epoxy primer coating which is applied via a High Volume Low Pressure (HVLP) spray gun process. Our primer coating is compatible with all popular alkyd, acrylic, and urethane refinish top coats. The following instructions will guide you in applying a durable, quality finish:


- 1. Clean all road dirt, diesel fumes, etc. off the unit. If you wash the unit with water, dry the unit thoroughly before beginning the next step.
- 2. Bring the unit to room temperature (minimum 70° F for most paint applications).
- 3. Sand the unit lightly with a random action sander and 220 grit abrasive. Just remove the glossy surface → DO NOT remove the primer to the bare metal. The primer is applied to a thickness of 1.2 mils. If the primer is removed below a thickness of 1.0 mil, it will be necessary to apply a coating of rust-inhibiting primer to restore proper rust protection to the unit.
- 4. If surface repairs are made which require sanding to bare metal, use an appropriate metal etching primer to ensure proper paint adhesion.
- 5. It is necessary to use a primer / surfacer between the primer and the base color coat when applying a base coat / clear finish to Venturo products.
- 6. Wipe the body down with a pre-paint surface cleaner (preparation solvent) to remove loose sanding waste and any accumulated debris.
- 7. Allow to dry and tack-off unit just prior to spraying.


NOTE: Low Volatile Organic Compound (VOC) paints, mandated in certain areas by government environmental regulations, have performance characteristics similar to base coat / clear coat paint systems; Venturo recommends the application of a primer between Venturo's primer and the top coat. The top coat supplier should recommend the primer compatible with their top coat.



#### **VENTURO CRANE BODIES – 6-YEAR LIMITED WARRANTY POLICY**



Venturo Crane Bodies are built to last...we guarantee it!
As a purchaser of any new Venturo crane body, you will receive 6 years of the most complete coverage available at no added cost to you.

#### Items Covered by Warranty and Duration

- 1. Products have a no rust-through guarantee to the first owner/user of record for six years from the beginning of the warranty period.
- 2. The door hinges are guaranteed not to fail to operate for six years from the beginning of the warranty period to the first owner/user of record.
- 3. The door latches and lock cylinders are guaranteed not to fail to operate for six years from the beginning of the warranty period to the first owner/user of record.
- 4. The compartment shelves are guaranteed for six years from the beginning of the warranty period to the first owner/user of record not to bend under the rated load of 250 pounds.
- 5. Defects from manufacturing workmanship and/or material not specified above will be covered by warranty inclusive of material and labor to first owner/user of record for one year from the beginning of the warranty period.
- 6. The warranty period begins on the date of purchase by the first owner/user of record or 6 months from the date the product is shipped from the Venturo factory, whichever occurs first.
- 7. This six year warranty applies only to products shipped from the Venturo factory after January 1, 2004.
- 8. Venturo will pay the cost of parts and labor to repair or replace as necessary the defective component.
- 9. Venturo reserves the sole right to inspect item(s) claimed for warranty and decide the best way to handle any and all claims, including the replacement or repair of the warranted part.

#### **Exclusions from Warranty**

- 1. Warranty applies to the Venturo Crane Body and excludes all add-on attachments not manufactured by Venturo and all modifications and alterations not performed by Venturo.
- 2. Accessory products that are included in a customer order but not manufactured by Venturo (i.e. air compressors, hydraulic pumps, liftgates, generators, etc.) are covered by the accessory product manufacturer's warranty in effect at the time of delivery.
- 3. Paint or decals required following repairs or replacement of parts under warranty after one year from date the warranty period begins.
- 4. Products which have been misused, abused or damaged, inclusive of, but not limited to, accidents.
- 5. Fatigue cracking of the body structure caused by improper mounting, overloading, severe off-road applications, or shock loads induced by cranes or aerial devices.
- 6. Specific non-rust-through and paint warranty exclusions:
  - a. Products which have been used to carry corrosive materials, where such materials result in rust-through conditions.
  - b. Products purchased by the first owner/user in prime paint.
  - c. Products being warranted under the no rust-through warranty must have a hole rusted through the metal.
  - d. Rust on painted surfaces is not considered rust-through.
  - e. Paint deterioration caused by chemical reactions including, but not limited to, acid rain, industrial fallout or improper cleaning materials.
- 7. Products purchased or used outside the U.S.A. and Canada.
- 8. Products not properly maintained per Operator's Manual.
- 9. UNDER NO CIRCUMSTANCES, WHETHER IN CONTRACT, TORT, OR OTHERWISE, SHALL VENCO VENTURO INDUSTRIES LLC OR ITS AFFILIATES' AND SUBSIDIARIES' OR THEIR RESPECTIVE DIRECTORS', OFFICERS', SHAREHOLDERS', EMPLOYEES' OR AGENTS' (HEREINAFTER COLLECTIVELY "VENTURO") TOTAL LIABILITY ARISING IN CONNECTION WITH THE SALE EXCEED THE AMOUNT OF ANY SALES OR OTHER PROCEEDS RECEIVED BY VENTURO PURSUANT TO ANY CONTRACT OF SALE OR PURCHASE ORDER.
- 10. UNDER NO CIRCUMSTANCES, WHETHER IN CONTRACT, TORT, OR OTHERWISE, SHALL VENCO VENTURO INDUSTRIES LLC BE LIABLE FOR LIQUIDATED, SPECIAL, INDIRECT, INCIDENTAL, EXEMPLARY, OR CONSEQUENTIAL DAMAGES, EXPENSES, OR COSTS, INCLUDING, WITHOUT LIMITATION, LOST PROFITS, HOWSOEVER CAUSED AND EVEN IF THE POTENTIAL OF SUCH DAMAGES WAS DISCLOSED AND/OR KNOWN.
- 11. VENCO VENTURO INDUSTRIES LLC HEREBY DISCLAIMS AND EXCLUDES ANY OTHER EXPRESS, IMPLIED, OR STATUTORY WARRANTIES, ARISING BY OPERATION OF LAW OR OTHERWISE, INCLUDING, WITHOUT LIMITATION, ANY WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE.
